- 8 or 12 week Seminar I workshop

Additionally, you should also have and use your own WRAP®, or assisted and supported another person in developing and using their WRAP®. All Seminar I prerequisite course must be conducted by a WRAP® Facilitator.

Note: Participation alone is not a guarantee of certification. Participants are expected to demonstrate a core set of values and ethics. Course instructors will make every effort to work with participant toward successful completion of the course and/or establish next steps for certification.
