More than 113 million American lives change for the better as parity becomes law, requiring mental health and addictions coverage equal in scope to other medical benefits.

The phase out of Medicare's highly discriminatory 50 percent mental health copays gives 43 million elderly and disabled Americans much-needed access to care.

More than 300,000 veterans suffering from mental illness and addiction disorders are allowed to seek care at their local behavioral health organizations.

The Second Chance Act and Mentally Ill Offender Treatment and Crime Reduction Act ensure that more than 740,000 incarcerated individuals with mental illness and addiction disorders receive appropriate treatment and supports.
