### **Implementation Practices**

- WR is committed to providing an environment that affords people of all ethnic and cultural backgrounds an opportunity to achieve health and wellness. All direct clinical staff must demonstrate cultural competence through one-on-one supervision and via annual written testing. Assessing cultural and linguistic needs is an integral part of the agency's initial and comprehensive assessments. The organization has a multi-cultural diversity plan which tracks the staff, leadership, and board of directors ethnicity, and focuses on having it reflect the community served.
- WR will monitor the enrollment and progress of individuals by race, ethnicity, gender and LGBT status. In response to results, outreach and engagement efforts will be revised to address shortfalls in these areas, as they are observed.

## **Implementation Practices**

- Data assessment will be conducted in order to obtain participants' feedback via interview, focus groups or survey, will query for feedback on what could make program service entry more successful. Data on race, ethnicity, socioeconomic status, mental health status, and LGBT status can be used as a control variable in data analysis.
- Intake forms and the electronic care record (ECR) were reviewed and revised to collect subpopulation data. For example, WR was not asking about LGBT status prior to this project.
- To assist consumers with ACA enrollment, WR applied for and was accepted into the Whole Health Insurance Exchange Certified Application Counselor program.

## **Challenges and Barriers**

 The project location is a medically underserved and health professional shortage area. In a study of the community in which the project is located it ranked last for physical environment, in the last quartile for health outcomes, morbidity, health factors and health behaviors; and in the bottom half for social and economic factors, clinical care, and mortality. Below is information concerning race and gender for the project and community.

### **Data & Collection Measures**

- WR adheres to the HHS published final standards for data collection on race, ethnicity, sex, primary language and disability status, as required by Section 4302 of the Affordable Care Act in October 2011. This data is collected at intake and used, as appropriate, as a control variable in evaluating program outcomes. The data is self-reported, that is, the individual project participant provides the information requested on race, gender, LGBT status, etc.
- Data on participant gender and LGBT status is obtained by asking two separate questions: The first question asks the participant to report his/her gender, and the second asks them to report their LGBT status. The data collection measure for LGBT status uses the National Coalition for LGBT Health recommendation and is as follows:
  - Do you consider yourself to be one or more of the following:
    - Straight
    - Gay or lesbian
    - Bisexual
    - Transgender
    - [Add option for respondent to name another category if feasible for the survey]


• WR is examining HIP enrollment data to identify and address disparities. Early project data includes the following:
