

Challenges for Justice-Involved Individuals with MH/SU Concerns – Incarcerated Individuals

- Individuals with behavioral health issues are overrepresented in jails and prisons
- Arrest and incarceration often destabilizes a person
 - Loss of employment, housing, interrupted or loss of access to physical and behavioral health care, family, supports, etc.
- Individuals with MH/SU challenges stay in jails longer, have increased risk of self-harm and receive more frequent punitive responses
- There is a high prevalence of trauma occurring prior to and during incarceration. Significant risk of retraumatization during incarceration, especially for those in marginalized groups.
- Upon release, they are at greater risk of re-incarceration, emergency dept. use, hospitalization, homelessness, and death by overdose

Risk of Overdose Death Post Release

- About 60% of State and Federal prisoners have Substance Use Disorder (SUD), often
 Opioid Use Disorder (OUD)
- Individuals with SUD likelihood of death of overdose increases 12-fold the 2 weeks post incarceration
- Individuals with OUD -risk of overdose death is 40 times that of the general population
- There is also an increased risk of suicide among individuals reentering communities post incarceration

Community Corrections Programs

- Community Corrections
 Programs monitor and supervise a justice-involved person in the community
 - o Probation
 - o Parole
 - o Treatment Courts



Challenges for Justice-Involved Individuals with MH/SU Concerns – Community Corrections Programs

- May have many steps to follow or things to do/change to be considered in compliance with the criminal justice supervision
- Likely required to be in a behavioral health treatment program
- May be required to be abstinent of all substances
- Poor communication between community corrections program and treatment providers can add extra challenges to the individual
- One's behavioral health provider not incorporating justice involvement into treatment planning

Challenges for Behavioral Health Care Providers Working with Justice-Involved Individuals

- Understanding the criminal justice system and how the justice-involved person is impacted
- Knowing how to assess and incorporate into treatment planning
- Information sharing with the community corrections program or other criminal justice professionals
- Biases
- Being seen by the justice-involved individual as an extension of criminal justice system = difficulty in building a therapeutic relationship

Addressing the Concerns

- Jail-Based Treatment Programs and Services
- Reentry Services
- MOUD for Incarcerated Individuals, including methadone access
- Justice-Involved Program
- Housing

- Treatment started while a person is in jail or prison can begin the process of therapeutic change and continuing treatment upon reentry into the community can sustain these gains
- Jail-Based Program Team Consists of:
 - o Supervisor
 - o Counselors
 - o Peers

- Jail-Based Program Team Provides:
 - o Individual and Group Counseling
 - Interactive journaling
 - Seeking Safety and Living in Balance (groups)
 - Assessment and referral to MOUD services
 - Address criminogenic factors and recidivism risk
 - Recurrence Prevention Planning and Discharge Planning
 - Peer Services
 - o Communication and Coordination with Correctional Staff
 - o Follow up with individuals 30 days post release

- Reentry Team Consists of:
 - o Supervisor
 - o Case Managers
 - o Outreach Specialist
 - o Peers

- Reentry Team Provides:
 - Intensive Case Management in preparation for release setting up appointments, housing, transportation, ensuring they have their ID and reinstated health insurance upon release, etc. – and post release
 - o While individuals are still incarcerated provide groups MISSION-CJ
 - o Peers meet with individuals while incarcerated, attend court with them, and provide supports post release
 - o Team follows individuals for 1 year post release and provide support throughout the transition period
 - o Continued outreach to those who are transferred to DOCCS and will pick up working with them if/when released back to community

Opioid Treatment Program (OTP) and Coordination with Jails and Prisons

- Incarcerated individuals wishing to continue with methadone maintenance or begin methadone maintenance can do so
- BestSelf OTP works directly with Erie and Niagara County Jails and New York State Dept.
 Of Corrections and Community Supervision (DOCCS) Collins Correctional Facility, State
 Prison, to provide methadone to individuals within those facilities
- Note these facilities provide buprenorphine products through their own medical units, so incarcerated individuals seeking MOUD have choice

Justice-Involved Program

- BestSelf has this program in place to help bridge the gap that exists between our clinicbased services and the community corrections programs, as well as provide additional support to our clinicians who are working with justice-involved clients
- Newer program rooted in the understanding that collaboration between the behavioral health care provider and criminal justice professionals improves health and social outcomes for justice-involved people... and we have work to do here
- We want to make sure that our clinicians have a holistic approach and a better understanding of the client's experience within the criminal justice system and how that impacts various aspects of their life

Justice-Involved Program

- We want to have a positive impact on how community corrections programs view individuals with MH/SU challenges who are working with us in treatment and be able to understand their challenges and gains
- Justice-Involved Team Consists of:
 - Supervisor
 - Court Liaisons
 - Support Staff
 - Also works collaboratively with several other departments across the organization

Justice-Involved Program

- Justice-Involved Program Team Provides:
 - Support to clinicians in working with justice-involved individuals and communication with local drug and mental health courts
 - o Attend drug and mental health courts to speak on behalf of the individual's treatment, speak with the individual while at court to provide support and additional guidance, as needed, and support the individual's treatment goals
 - o Provide trainings
 - o Work with Champions

Housing

- Housing Specialists, in coordination with the Reentry team, will meet with individuals
 while incarcerated to review housing options available and begin the process to obtain
 housing
 - o Several different types of housing options are available with different eligibility criteria
