Licensure exams are a critical step for clinicians on their pathway to licensure, but the process can be challenging - and pass rates vary significantly by test-taker demographics.





# > The Gap

#### Summary: The Gap

We are experiencing an acute and sustained mental health workforce crisis in the United States. Despite the acute need for more clinicians, we lose thousands of licensure-track therapists from the workforce every year due to candidates' inability to pass licensure exams.

And those outcomes are not evenly distributed by demographic: more than 30% fewer Black-identifying test-takers pass their licensure exams than their White-identifying counterparts.

Every newly licensed clinician will support thousands of clients seeking care over their career – so every "lost clinician" means thousands of missed clinical care-giving opportunities. And with those lost clinicians not being evenly distributed by demographic, that loss is also felt disproportionately across those communities that they would have otherwise served.

#### **ASWB Report Overview**

- Published in August 2022, reports outcomes over prior year (2021) and prior eleven year (2011-2021) periods
- Reports data separately for each Clinical, Masters, and Bachelors exams
- For each exam, reports the following data for each period:
  - # of test takers
  - First-time test taker pass rates
  - Ultimate pass rates
  - Performance splits by demographic: race/ethnicity, gender, age, and primary language
- As noted, ASWB is not the only testmaker in behavioral health, and social work exams are not the only licensure exams, but 1) ASWB (to its credit) has produced the most robust recent reporting of any testmaker, and 2) we expect that other licensure exams in behavioral health would show similar results



ASWB has altered the response options available on the exam registration forms and will continue to evaluate these options to ensure test-takers may accurately respond.




#### **ASWB Report Details: Clinical Exam Pass Rates**

#### **ASWB Report Summary**

- Overall pass rates have remained relatively flat over the past four year period, but still lag behind other comparable exams (e.g. NCLEX: first-time pass rate for US-educated test-takers = 90%)
- We are losing thousands of would-be clinicians every year based on failure to pass licensure exams

#### Exam Preparation - Overview

Across a range of educational testing, three particular things have been demonstrated to improve outcomes the most:

- Early access. The best time to start preparing for licensure exams is today. Most successful test-takers prepare for 3-9 months, but preparation can start as early as during grad school.
- **Realistic practice.** Practice doesn't make perfect; perfect practice makes perfect.
- Accountability partners. Whether a study group or a 1:1 coach, having someone in your corner can help you stay on track with your preparation.



#### **Keys to Successful Exam Preparation**

- **Start Early.** Even if you are not planning to test for two years, you can start by exposing yourself to test-like content now.
- **Build a Study Plan.** Like any journey, having a map is key to getting to your destination.
- ...and Make it Manageable. Some studying every week is better than a lot of studying in the final month.
- **Review Wrong Answers.** Reviewing answers is arguably more important than taking practice questions.
- ...and Right Ones. If you got a question right for the wrong reason, that won't be replicable on test day.
- Incorporate Full-Length Practice. Exams are a marathon, not a sprint.
- **Establish a Support Network.** Don't go it alone.

- Support licensure-track staff with exam prepresources



#### Support through Continuing Education Budget

Although the cost of exam prep is relatively low - a comprehensive package for social work exam prep through AATBS, for example, is under \$300, and many individual prep assets are available for under \$100 - licensure-track staff also have to bear the cost burden of exam fees (also several hundred \$) and are typically early-career professionals with relatively lower total compensation than their fully licensed colleagues.

Many organization have budget dollars allocated to continuing education (and/or professional education, more generally, and/or training) - using these monies to pay for exam prep can alleviate the cost burden on licensure-track staff, thereby leveling the playing field.

Investing in the exam success of your licensure-track clinicians can be used as a retention tool (since you're supporting them through test day) <u>and</u> a recruitment tool (since you can demonstrate that support to candidates).



#### Support through Allowable Cost (PPS CCBHCs)

Prospective Payment System (PPS) CCBHCs can incorporate exam prep into their allowable costs under 2 CFR 200.473.

#### § 200.473 Training and education costs.

The cost of training and education provided for employee development is allowable.

[78 FR 78608, Dec. 26, 2013. Redesignated at 85 FR 49570, Aug. 13, 2020]

Depending on the state and the covered scope of service, this can be included as a direct cost, using line 27 in the cost accounting report.

Additionally, grant-recipient CCHBCs can earmark monies for training and education, including exam prep (similar to any community mental health organization that invests in the development of its staff).



#### Support through Payviders (and/or other Grant Funding)

Triad is currently partnered with Kaiser Permanente (in partnership with the National Council) and Optum to support candidates (particularly minoritized candidates) through placement at providers, exam prep, and clinical supervision.

We hope to see both the KP and Optum programs expand over time, and we expect that there will continue to be funding opportunities through payviders, federal, state, and county budgets, and philanthropic efforts.
