

Integrating Behavioral Health and Housing Supports: CCBHC and Medicaid Housing-Related Services Crosswalk

Overview

Certified Community Behavioral Health Clinics (CCBHCs) are designed to deliver comprehensive, community-based mental health and substance use services, with a strong emphasis on care coordination, accessibility, and engagement beyond the clinic walls. As the affordable housing crisis has deepened, many behavioral health agencies have expanded their efforts to include housing and homelessness support.

The 2023 CCBHC Certification Criteria encourages partnerships with agencies that offer housing and homelessness services when those service participants have behavioral health needs.¹ The criteria also require CCBHCs to offer care coordination services in a variety of settings where people with behavioral health needs are found. Still, financing and infrastructure for these services often fall short of demand, limiting their scalability and sustainability.

States that have adopted CCBHCs as part of their Medicaid State Plan and those that offer housing-related services (HRS) through Medicaid present a unique opportunity for alignment. By integrating these two Medicaid-funded strategies, states can build more sustainable, cross-sector approaches to supportive housing for individuals with behavioral health needs.

This document provides a crosswalk of current state-level activity related to CCBHC implementation and Medicaid coverage of HRS. It outlines where each state stands in advancing these initiatives, identifying overlaps and gaps. Blank fields indicate states that either do not offer HRS through Medicaid or have not made significant progress in implementing CCBHCs within their Medicaid programs.

This crosswalk is intended to inform planning, foster collaboration, and highlight opportunities for more coordinated behavioral health and housing systems across the country.
